INFORMATION

Description of proposal

Retrospective construction of a transparent verandah and deck area in front of a dwelling on a lot less than 500sqm. Contested condition 1a) requires that requires the roof of the verandah to extend no more than 3m north of the existing front northern façade of the dwelling.

Conditions 1b) and 3 were agreed between parties to be deleted as unnecessary.

Nature of proceeding

Application under section 80 of the *Planning* and *Environment Act 1987* – to review the conditions contained in the permit.

REMARKS

- Application for review P1670/2018 sought a review of conditions 1a), 1b) and 3 of permit TPA/48670.
- Oral reasons for the decision of the tribunal were given at the conclusion of the hearing about why an order is made to delete condition 1a).
- Written correspondence from the council received prior to the hearing advised that the council consents to the deletion of conditions 1b) and 3. The council confirmed this position at the commencement of the hearing.
- Based on reasons given at the hearing for the removal of condition 1a) and the consent by council to delete condition 1b), the preamble of condition 1) to 1a) and 1b) becomes unnecessary. The order therefore requires all of condition 1) to be deleted. The order also directs deletion of condition 3) as consented to by the council.
