  - Delete condition 2 jj), 2 ll) and 2 mm)

  - New conditions 2 jj), 2 kk), 2 ll), 2 vv), 2 ww) and 2 xx).
  - Correction to condition 9
  - Amend condition 20(c)
  - Two new conditions at condition 21, and 22.

1.3 Monash Planning Scheme – Potential Unintended Use and Development Exemptions in the Residential Zone Provisions

Moved Cr McCluskey Seconded Cr Little

That Council:

- Notes that in a recent VCAT Direction, VCAT questioned whether a planning permit
  is required for the construction of a dwelling on land already containing a
  Rooming House.
- 2. Notes that there are potential unintended use and development exemptions in the Residential Zone provisions arising from recent State Government changes to the planning provisions for Rooming House, Residential Building and other accommodation uses, in particular the potential exemption from a planning permit where a dwelling is proposed to be constructed on land containing an existing rooming house or residential building.
- 3. Resolves to write to the Minister for Planning alerting him to the question posed by VCAT and potential unintended consequences arising from the current drafting of the planning scheme and request an urgent Ministerial amendment to all Victorian planning schemes to ensure that construction of a dwelling on land where there is an existing residential building/rooming house requires a planning permit.

# 1.4 Instrument of Appointment and Authorisation – Planning and Environment Act 1987

# 1.5 School Crossing Supervision Tender

- Waverley Night Netball Association Waverley Women's Sports Centre, 2-30
   Jells Road Wheelers Hill (refer to Attachment 1)
- 2. Incorporating the following terms and conditions:

Rent: \$15,000.00 per annum (plus GST)

Term: 10 Years Further Term: 5 Years

Use: The organising of competitions, training, and other activities

directly associated with the sport.

- 3. Give public notice of the Proposal in accordance with the Monash Community Engagement Policy as required by Section 115 (4) of the Local Government Act (2020) (the Act), in a daily newspaper and on Council's website from 1 March 2022 and invite submissions on the Proposal.
- 4. Authorises Council's Chief Executive Officer or her delegate to undertake the administrative procedures necessary to enable Council to carry out its functions in accordance with the Community Engagement Policy in respect of the Proposal. ('Appointed Officer').
- 5. Appoint a Committee of Council comprising of the Mayor and Mulgrave and Mount Waverley Ward Councillors to meet to consider the outcome of the public notice referred to in point 3 above, and to hear and consider any submitters requesting to be heard in accordance with the Community Engagement Policy at 7pm on 17 May 2022 at the Monash City Council Civic Centre, 293 Springvale Road Glen Waverley.
- 6. Notes that following the meeting referred to in point 5 above, and consideration of any submissions, that the Committee of Council provide a report to Council on its considerations including a summary of any submissions and make a recommendation to Council on whether or not to proceed with the Proposal.

# 1.7 Road Discontinuances - Mount Waverley Reserve

#### That Council:

- 1. Notes that Council, at its meeting on 27 July 2021, adopted the draft Mount Waverley Reserve Masterplan for consultation and at its meeting on 30 November 2021, Council endorsed the Mount Waverley Reserve Masterplan.
- Notes that the 27 July 2021 Council report highlighted the numerous parcels of land currently forming Mount Waverley Reserve that have the legal status of a road, a status which is not required for current or future use. These roads are identified on the Title Re-Establishment Survey for Mount Waverley Reserve in Attachment 1.
- 3. Notes the current and proposed future uses of the land that forms the roads and agrees that:
  - a. The road status should be removed (discontinued) from the areas shown on the Plan for Road Discontinuance Purposes in Attachment 2 pursuant to Section 206 and Clause 3 of Schedule 10 of the Local Government Act 1989 (Vic) ('Act') and the land consolidated within the surrounding land that forms the Mount Waverley Reserve as part of a Plan of Consolidation.
  - b. A small section of the road in the North East corner of Gwynne Street will become an extension of Fleet Street as part of the Plan of Consolidation process in order to protect the existing in-situ asset owned by United Energy Limited.
- 4. Resolves to commence the statutory procedures pursuant to Sections 207A and 223 of the Act to consider discontinuing the area of roads shown on the Plan for Road Discontinuance Purposes in Attachment 2 pursuant to Clause 3 of Schedule 10 of the Act ('the Proposal').
- 5. Gives public notice of the Proposal in accordance with Sections 207A and 223 of the Act in a daily newspaper and on Council's website from 1 March 2022 and invite submissions on the Proposal.
- 6. Authorises Council's Chief Executive Officer or her delegate to undertake the administrative procedures necessary to enable Council to carry out its functions under Section 223 of the Act in respect of the Proposal ('Appointed Officer').
- 7. Appoint a Committee of Council comprising of the Mayor and Mount Waverley Ward Councillors to meet to consider the outcome of the public notice referred to in point 5 above, and to hear and consider any submitters requesting to be heard in accordance with Section 223 of the Act at 7.15pm on 17 May 2022 at the Monash City Council Civic Centre, 293 Springvale Road Glen Waverley.
- 8. Notes that following the meeting referred to in point 7 above and consideration of any submissions, that the Committee of Council provide a report back to Council on its considerations including a summary of any submissions and make a recommendation to Council on whether or not to proceed with the Proposal.
