Feedback Report – Suburban Rail Loop East Glen Waverley Activity Centre Consultation

PROJECT BACKGROUND

The proposed Suburban Rail Loop (SRL) will be a new 90 km railway line that will link all the major metropolitan rail lines (including the Glen Waverley Line) to improve public transport options for getting around Melbourne. With a station to be built at Glen Waverley, it will be possible to catch the train from Glen Waverley to Monash University, Deakin University, Southland, Box Hill and Melbourne Airport (as well as many other options).

The SRL East project is currently in a planning and approval phase that is being overseen by the Suburban Rail Loop Authority (SRLA). Council has been engaging with the SRLA for approximately 18 months about the new Glen Waverley Station. However, there is increasing concern that the SRL Authority is not giving sufficient consideration to how the new station will connect with the existing area around it.

The approval phase of the project includes the Environment Effects Statement (EES) process. The EES was exhibited between 5 November and 16 December 2021 and the public hearing was held from 28 February to 5 May 2022.

Monash City Council held two online community Information sessions on the EES on 10 and 17 November 2021. These were well attended, with approximately 150 and 170 participants respectively.

The Public Hearing allowed for the Proponent (SRLA) to set out its case and provide evidence in support of the Project, and Municipal Councils (including Monash City Council), agencies, community groups and submitters to speak to their submissions and call evidence.

SUMMARY OF ENGAGEMENT

Following liaison with the Glen Waverley Activity Centre (GWAC) Committee, Council sent out a letter and brochure to 22,543 owners and occupiers in the Glen Waverley 3150 postcode, inviting feedback on Council's concerns with the SRL project at Glen Waverley and also inviting their attendance at a Community Information session held at the Civic Centre, Glen Waverley and via Zoom at 6pm on Wednesday 13 July 2022.

The Community Information session was also promoted in the July Edition of the Monash Bulletin, which was published on 15 June 2022.

The Community Information session held at the Civic Centre, Glen Waverley (and via Zoom) was chaired by Mayor Stuart James, with Glen Waverley Ward Councillors Geoff Lake and Nicky Luo, and Council officers also in attendance. Representatives from the SRLA also attended. Council Officers presented Council's main concerns with the proposal at Glen Waverley: being the lack of interchange between the existing Glen Waverley station, bus interchange and the proposed SRL station; the permanent closure

of Coleman Parade; and the impact on parking. Participants were then invited to share their views on the project.

The consultation period was open from 15 June to 31 July 2022.

ENGAGEMENT RESULTS

Summary of Feedback

723 submissions were received during the consultation period on Council's concerns with the SRL project at Glen Waverley. Approximately, 150 people attended the Community Information session held at the Civic Centre, Glen Waverley and via Zoom on Wednesday 13 July 2022.

The overwhelming majority of participants supported Council's position. More than 95% supported the undergrounding of the existing Glen Waverley station to create a connection between the new SRL station and the existing one.

Quantitative feedback


Council sent out a letter and brochure to 22,543 owners and occupiers in the Glen Waverley 3150 postcode and 723 submissions were received in response to the consultation. This is a response rate of 3.2%.

Would you expect to see at the very least, a below ground enhanced interchange for public transport users to move quickly, easily and safely from one station to the other?







Information provision

An announcement was included on Council's website on 4 July promoting the consultation and Community Information session.

The Community Information session was held at the Civic Centre, Glen Waverley and via Zoom at 6pm on Wednesday 13 July 2022.

UPDATE on Suburban Rail Loop

Council will hold an information session on the status of the State Government's Suburban Rail Loop project and outline and seek views on several issues Council has identified for Glen Waverley arising from the project.

The information session on Wednesday 13 July will include an update on the 10-week hearing of the Environment Effects Statement (the impacts of the project on the local environment). A report will be prepared for the Minister for Planning on the outcomes of the hearing by Thursday 23 June 2022. The Minister's assessment report is expected in August 2022. All documents tabled at the hearing, including Council's contribution on behalf of the community, can be found on the Suburban Rail Loop East Inquiry and Advisory Committee Engage Victoria web page.



Several key issues identified in Glen Waverley as part of this project include:

- » Proposed road closures (partial closure of Coleman Parade between Kingsway and the ramp entry to Ikon) leading to increased traffic congestion on Kingsway. We want to see second traffic crossing between Myrtle St and Railway Pde North to limit traffic through Kingsway and better connect existing and proposed carparks
- » Replacement and additional provision of parking. Council had previously committed to build a new 1,000 space multi-level car park on the current Montclair car park. This site will now be used for the SRL station build and these carparks need to be provided/replaced in convenient and accessible locations in the Activity Centre
- » Opportunities for significant improvements in the Activity Centre that are not supported or being considered as part of the project. This includes Council's long-standing plans for a ring road around Glen Waverley and relocating or grade separating of the existing rail line
- » Support for traders. Our traders have already suffered the damaging effects of the pandemic over the last few years. Construction of the SRL will impact on this area.

The Suburban Rail Loop project will be transformational for the Activity Centre. As a catalyst project Council believes that the project can deliver on many long-term visions such as those in the Glen Waverley Activity Centre Structure Plan, but overall we are seeking better outcomes for Glen Waverley once the construction is completed. There is a real opportunity for these to be delivered as part of or as a consequence of the project, and we fear that not doing so is a missed opportunity to deliver improvement across the whole Activity Centre so that it continues to be a connected, vibrant, thriving precinct. The focus of the SRLA to date in our view has been too narrow.

Whilst we have been working with the SRLA for some time, and support the project, unfortunately, the SRLA does not as yet share Council's

aspirations and vision for the future of the Activity Centre and support works that will bring unquestionable improvements such as moving or grade separating the existing Glen Waverley Station, constructing the ring road and providing for convenient and accessible carparking in the right location.

Dear Resident,

The Suburban Rail Loop and the future of Glen Waverley

We are writing to you regarding the Suburban Rail Loop (SRL) project. This project is a game-changer for transport in Victoria – and for shaping Glen Waverley's future. Done right, it represents a once-in-a generation opportunity to set the course for Glen Waverley for the next 50 years. However, Council is concerned that the currently proposed Glen Waverley SRL Station will significantly impact and stunt Glen Waverley's future.

The purpose of this letter is to let you know what is being proposed, what Council's key concerns are and to seek your feedback.

The Suburban Rail Loop

The Suburban Rail Loop will be a new 90 km railway line that will link all the major metropolitan major rail lines (including the Glen Waverley Line) to improve public transport options for getting around Melbourne. With a station to be built at Glen Waverley, it will be possible to catch the train from Glen Waverley to Monash University, Deakin University, Southland, Box Hill and Melbourne Airport (as well as many other options).

The SRL project is currently in a planning phase that is being overseen by the Suburban Rail Loop Authority (SRL Authority). Council has been engaging with the SRL Authority for about 18 months about the new Glen Waverley Station. However, we are increasingly concerned that the SRL Authority is not giving sufficient consideration to how the new station will connect with the existing area around it.

Council's concerns

Council has three main concerns with the proposed Glen Waverley SRL Station. These are briefly summarised below and in the attached information flyer.

1. The lack of connection between the new SRL station and the existing Glen Waverley Station

The SRL station and the Glen Waverley Station will not be connected (see the image on the flyer). The SRL station will be built on Council's existing Montclair car park behind Mocha Jo's and the Waverley RSL (the land is going to be compulsorily acquired from Council). Commuters will need to leave one station and cross Coleman Parade to access the other and the SRL Authority is proposing



to close this part of Coleman Parade to traffic. Council believes this is a missed opportunity to have a more integrated and connected station, similar to the Box Hill station which is below a shopping centre. This would also allow for a long overdue enhancement of the existing Glen Waverley Station. The SRL Authority has advised this is outside of its scope. We think this is too short-sighted and fails to take an appropriate whole-of-government approach to this project. At the very least, we believe there should be a below ground interchange for pedestrians to move quickly and easily from the new station to the existing one.

2. The SRL Authority is proposing to permanently close part of Coleman Parade

The SRL Authority is proposing to close Coleman Parade (see map on the flyer) west of Kingsway for approximately 80m. They say this is needed to allow passengers to walk between two stations. However, there are better ways to connect the two stations, such as through a below ground interchange (see point 1 above) and we don't support this closure. Of most concern, the closure of Coleman Parade will lead to significantly increased traffic on Kingsway - including buses and trucks - as all traffic using Coleman Parade will be diverted to Kingsway's busiest section between Bogong Avenue and Coleman Parade. We see this as a real threat to the future of Kingsway and Glen Waverley. Kingsway is already heavily congested and that is just from the local traffic accessing parking and shops. If all traffic using Coleman Parade to get to and from Blackburn Road is to be diverted through the entire length of Kingsway, this will radically change how the road and the shopping strip functions in the future. Council has been planning a major upgrade to Kingsway to widen pavements, remove the kerbside parking and calm the traffic on it by giving much greater priority to pedestrians. However, that vision will be impossible to deliver under the SRL Authority's plans. These issues could easily be overcome by an extension of Myrtle Street across the existing rail line to Railway Parade North to create a ring road around the activity centre. This ring road has been earmarked by Council since the 1960s and was a key part of the Glen Waverley Structure Plan which was adopted in 2014. However, the SRL Authority are not interested in even looking at this they say it is outside of their scope and not their problem.

3. Impact on car parking

Council had previously committed to build a new 1,000 space multi-level car park on the current Montclair car park which is being acquired for the new station. Just before the commencement of this project, it had to be shelved because of the SRL Authority's decision to acquire this land from Council for the new SRL station. Not only is this new car park impacted, but the 297 existing car parks will be lost. In response, Council is urgently examining other options to address these parking impacts. Some of these parking spaces will be able to be added to the Bogong Avenue Carpark with Council planning to build extra levels there ahead of SRL construction commencing. However, not all the required spaces can be provided at Bogong, and we are continuing to negotiate with the SRL Authority in relation to the rest of the replacement parking required. They have nominated a site north of the railway line (the O'Sullivan Road existing carpark) for temporary replacement parking and as a potential permanent location for these parking spaces. However, without the ring road extension mentioned above, this parking is remote to the heart of Kingsway. Indeed, this parking is even further away than Council's Euneva Multi Deck Car Park which was built 10 years ago and has

never lived up to expectations in terms of its utilisation because it is too distant to activity on Kingsway. Council believes more parking needs to be built south of the existing railway line once the new station is constructed to replace the parking that is to be displaced.

In addition to the above issues, Council also wants to see appropriate support and assistance provided by the SRL Authority to Glen Waverley's traders on and around Kingsway. Our traders have suffered the damaging impacts of the pandemic over the last few years. The 10+ years of construction of the SRL and loss of car parking for their customers will likely have an even more significant impact on their businesses.

As a major infrastructure project, Council believes the SRL can unlock Glen Waverley's potential and set it up for the next 50 years. However, an approach which only cares about building a station as quickly and cheaply as possible and which fails to integrate it with its surroundings (particularly the existing station), has the potential to stunt Glen Waverley and make it less liveable.

Next steps

WHAT IS PROPOSED BY SRL AUTHORITY AND WHAT WE WANT

Point 2:

The closure of Coleman Parade will increase traffic on Kingsway as traffic is diverted through this area. Our vision is to reduce traffic on Kingsway, remove some kerbside parking, and widen footpaths. If Coleman Pde is closed, Council wants Myrtle St to be extended across a lowered railway line to create a ring road, reducing traffic being pushed onto Kingsway. The SRL Authority does not agree and says it is not part of their project.



Point 1:

No connection between the new SRL station and the existing GW station. The SRL Authority want to close Coleman Parade to create a pedestrian area, the only link between the two stations. An underground pedestrian connection between the two stations is a better option, resolving the need to close this road.

Proposed closure of Coleman Parade

Point 3:

- Purple zone: SRL site for temporary (possibly permanent) commuter parking for approx. 370 cars.
- ② Blue zone: Montclair site. Currently has 297 parking spaces and was location for Council's planned up to 1000 space multi-level car park. This is not progressing as SRL will acquire this land for its use. They are proposing 297 current spaces be relocated to the purple area. We want more parking in central Glen Waverley (south of the rail line)
- Sorange zone: Council is considering an extension to the Bogong car park to offset some of the lost parking spaces from the abandoned mult-level Montclair car park.
- Red zone SRL station
 White: parking
 Blue lines: SRL rail line
