

# **ANNUAL REPORT SUMMARY**

### **About this report summary**

This Annual Report Summary provides a brief account of Council's performance from 1 July 2011 to 30 June 2012.

This summary provides information about Council's achievements in the 2011-12 financial year. It also identifies our key priorities, long-term objectives and future challenges. A more detailed account is provided in Council's 2011-2012 Annual Report.

The City of Monash Council Plan 2009-2013, Budget 2011-2012, Business Plan 2011-2012 and Monash 2021 are the guiding documents for the Annual Report. Those documents outline our objectives, targets and key strategies to meet our goals. Our central goal is to ensure that Monash continues to be 'a thriving community'.

### **Our city**

The City of Monash is 82 km², located 20km southeast of the CBD and includes the suburbs of Wheelers Hill, Mulgrave, Glen Waverley, Mount Waverley, Ashwood, Huntingdale, Notting Hill, Clayton, Oakleigh, Hughesdale, Oakleigh East and parts of Chadstone, Burwood and Oakleigh South.

### **Highlights**

# **Environmental Sustainability Road Map**

Council allocated an additional \$200,000 from its 2011-12 Budget to implement actions from its four-year Road Map. Energy efficient lighting has reduced greenhouse gas emissions at five community facilities by 14%.



### **Euneva Project**

351 additional car spaces are now available in the heart of Glen Waverley, with the completion of this \$17.3 million project.



### Oakleigh's Eaton Mall

Stage two of this \$2.2 million beautification project is well underway.



### **Central Reserve Pavilion**

Was fully operational in October 2012, this \$1.8 million community pavilion will provide a new home for sports clubs.

### **CEO's Message**

Council has been busy in 2011-12, continuing to provide high quality services to our community while also launching several exciting new projects.

### **Advocacy**

We have taken a strong stance on two issues: reducing the harm caused by problem gambling and preventing family violence. We have been leading a campaign for the State Government to change the laws to reduce the high concentration of electronic gaming machines in vulnerable communities. We have also taken a proactive approach to preventing violence against women, and will soon begin a \$1 million three-year partnership project to reduce the incidence of violence against women and children.

### **Capital works**

Over the past 12 months, we have invested \$35.4 million in expanding and improving local community infrastructure. Local residents and businesses will benefit from the additional 351 car parks provided as part of the \$17.3 million environmentally-friendly building in Euneva Avenue, Glen Waverley and from a beautification of Oakleigh's popular Eaton Mall.

### **Sustainability focus**

Council allocated an additional \$200,000 from its 2011-12 Budget to implement actions from its

Environmentally Sustainable Road Map. The four-year plan sets out actions to meet measurable targets for energy, water, waste and food, natural environment, transport, and planning and design. We are making good progress, with the installation of energy efficient lighting at five community centres reducing greenhouse gas emissions 14%.

### **Celebrating diversity**

We are so pleased that Monash remains one of the most vibrant and culturally diverse municipalities in Victoria. Data from the 2011 Census revealed that nearly half (45%) of Monash's residents were born overseas. We will keep reviewing our services and programs to ensure they meet the specific needs of our community.

Finally, I would like to thank the Councillors and staff of the City of Monash for welcoming me back to the organisation as Chief Executive. I would like to thank former CEO David Conran for his excellent stewardship of the Council over the previous 17 years.

# 2.2 Forming partnerships with local business and industry to enhance local economy.

 About 140 people attended each of the six events associated with the Monash Business Awards

- Held two Economic Development Forum dinners, with about 80 people attending each
- Announced 2012 Monash World Environment Day Awards, with Wharington International Pty Ltd named as Sustainable Business Award winner
- Organised three Women's Business Network events, attracting an average of 110 people to each event
- The Monash Enterprise Centre held 126 events, housed a total of 38 tenants and facilitated business relationships with 104 associates

# 3.1 Working to improve local road and transport networks to manage movement within and across the city.

- Spent \$1.99 million on road reconstruction, with works completed in Atkinson Street, Oakleigh and along the Warrigal Road service road, Hughesdale. Reconstruction works began in Hamilton Street, Oakleigh, Caloola Avenue, Oakleigh, Railway Avenue, Oakleigh and Kanooka Grove, Clayton
- Invested \$1.89 million on drainage works, with major works in and around Smyth Street, Mount Waverley, Brandon Park Drive, Wheelers Hill and Remington Drive/ Waverley Road, Glen Waverley
- Spent \$914,000 on resurfacing the asphalt of various roads and car parks in Mt Waverley, Glen Waverley,

Ashwood and Mulgrave

- Cleaned 67,731 metres of drains
- Maintained more than 49km of off-road and 15km of on road bike paths
- Improved local bicycle paths, including a section of the Scotchmans Creek Trail between Forster Road and Waverley Road
- Issued 53,682 parking infringements, with 10,355 appeals lodged and 2,054 infringements withdrawn. The total parking revenue generated was \$3,87 million

# 3.2 Providing clear direction to ensure appropriate and high quality development and accessible safe public spaces.

 Incorporated an Amendment into the Monash Planning Scheme

- to provide guidance for future development in the Holmesglen Neighbourhood Activity Centre
- Adopted an Amendment to the Planning Scheme regarding the Oakleigh Major Activity Centre and submitted the Amendment to the Minister for Planning for approval
- Undertook stage one of a street furniture upgrade at the Glen Waverley Activity Centre and the Clayton Activity Centre
- Received 1064 town planning applications and issued 760 planning permits, 244 Notices of Decisions to grant a permit and 85 refusals to grant a permit
- 2,165 building permits valued at \$674 million issued by Private Building Surveyors and 160 building permits valued at \$7 million issued by Council's Municipal Building Surveyor or his delegate
- Carried out 1,384 building permit inspections
- Issued 465 notices and orders for illegal or non-complying building work, dangerous buildings and drainage issues
- Investigated 117 swimming pools to ensure the required safety measures were in place
- Undertook 5,399 inspections where building activity was taking place to ensure that community assets were protected

- \$125,762 allocated to remove graffiti, with contractors removing 5,198m<sup>2</sup> of graffiti from community assets
- 3.3 Maintaining and improving the condition of assets to ensure essential services are provided and the community has access to quality public buildings, parks and gardens.
- More than one million visits were made to the Monash Aquatic and Recreation Centre, a record number
- Achieved a 12% increase in annual attendance at the Oakleigh Recreation Centre and a 6% increase in annual attendance at the Clayton Aquatics and Health Club
- Upgraded sports lights at Mount Waverlev Reserve, Warrawee Park and Gladeswood Reserve Tennis Club as part of Council's annual Capital Works Program
- · Maintained 332 hectares of reserves and sports fields and 244 hectares of passive open space
- Began developing a Walking & Cycling Strategy to identify where improvements can be made
- Spent more than \$150,000 on upgrading playgrounds in five local reserves
- Completed consultation and design for the next accessible playground at Warrawee Park
- Invested \$120,000 for improvement works at the two local public golf courses

- Reduced greenhouse gas emissions from the Council vehicle fleet by 9.75%
- Installed water tanks at four community facilities, saving about 68 kilolitres of water per year
- Replaced cool season grasses with warm season grasses at three local sports fields, reducing water demands

- Achieved Gold level Waste Wise certification, demonstrating a strong commitment to reducing waste
- Spent \$3.4 million on sustainable products as part of the Ecobuy Program

- Managed 100,000 plus street trees as part of a cyclic maintenance program
- Inspected 4,114 public trees in response to community requests
- Adopted new guidelines for the management of trees following community consultation
- Installed more than 200 nest boxes suitable for native species in Monash reserves


- Continued to follow the long term strategy Monash 2021
- Published the Council Plan 2009-2013 (2012 update)
- Developed the Annual Business Plan, to ensure the short term focus of Council is on the achievements of the objectives in the Council Plan
- Increased rate revenue by 6%, in line with the Strategic Resource Plan

- Spent \$35.4 million on capital works, completing 85.6% of the budgeted program
- Achieved excellent results in the statewide Community Satisfaction Survey, scoring higher than the statewide benchmarks on four of the five core indicators.
- Held 12 Ordinary Council Meetings
- Received 19 Freedom of Information applications, with access granted to all
- Introduced Local Law No.4 to restrict smoking in and near Council buildings




### **Financial Sustainability**

Council's overall Financial Performance has improved considerably, with Council achieving a surplus of \$8.8 million in 2011-12 compared with a \$7.2 million deficit the previous year. Despite this surplus, Council does recognise a \$12.3 million liability for the payment of the Local Authorities Superannuation Fund unfunded liability.

Monash Council had the lowest levels of rates amongst its neighbours with a 6% increase in rates for the 2011-12 year. The table below shows how Monash compares based on the average rate (in dollar amounts) per assessment as compiled by the Municipal Association of Victoria.

Council's Balance Sheet is a representation of the overall state of Council's financial position. In 2011-12 Council's total equity, represented by total net assets, was \$2.06 billion. With more than \$2.0 billion in non-current assets (comprising Land, Buildings, Roads, Drains, Plant, Art, Library books and other infrastructure) and current assets of \$57 million, Council's overall financial position is very strong.

Overall, Council continues to be in a sound financial position with a positive working capital ratio (1:1) demonstrating Council's ability to meet its current commitments.

As detailed in Note 44 of the Financial Statements, Council's financial ratios remain healthy. Over the three years:

- · Debt Servicing Costs as a proportion of Total Revenue have reduced slightly at 0.45%
- Debt Servicing and Redemption Costs as a proportion of Rate Revenue have decreased from 3.19% to 2.95%
- Debt Exposure Costs as a proportion of Total Realisable Assets have increased from 4.11% to 5.4% due to increased borrowings to fund major capital works
- · Working Capital Ratio has decreased from 104,29% to 100.35%
- Adjusted Working Capital Ratio has decreased from 217.08% to 212.89%
