for a schedule of rates-based contract with an estimated cumulative contract value of \$9,150,000 for the initial term and an estimated total contract value of \$18,300,000 inclusive of all available extension options;

- 5. Notes that the contract will commence in February 2023, with an initial term of three (3) years and the contract has three (3) separate extension options of one (1) year each and authorises the Chief Executive Officer to approve extension options subject to satisfactory performance.
- 6. Notes that the estimated schedule of rates panel contract values stated above are also subject to an annual CPI indexation as per the contract.

INTRODUCTION

Council has conducted a tender for contract 2022173 - Building Design, Landscape Design and Project Management Services.

As part of its planning process for this tender, Council Officers considered its procurement options, including whether to go to market itself, participate in regional or sector collaboration or to access established contracts via other compliant Procurement agreements.

Due to the specialised range of professional services required and the broad scope of projects anticipated, Council Officers agreed to run a Council specific tender to achieve the best outcome for Council and as such, a collaboration with other councils was not considered as a viable option.

BACKGROUND

Council Officers sought to appoint three separate panels of professional services contractors for Building Design, Landscape Design and Project Management Services to support Council's internal resources during peak workload periods to assist with the delivery of Council projects. The panel will be used for engagements as required, for individual projects under the tender threshold (less than \$250,000) to assist with delivery of Capital Works projects. Projects above this threshold will continue to be procured via specific tenders.

Council Officers also estimated likely future workloads for these services based upon the Long-Term Capital Works Program and Council's Long Term Financial Plan and determined that a panel of between three to six contractors would be required for each of the service categories.

The initial contract term is three (3) years with three (3) separate one (1) year extension options available, executable at Council's sole discretion.

NOTIFICATION

A public notice was placed in The Age newspaper on Saturday 23 July 2022 and the tender closed on Friday 12 August 2022.

Tender Conformance:

DISCUSSION

The evaluation panel confirmed that no more than five contractors are required for each of the Building Architectural and Landscape Architectural Services categories and that no more than four contractors are required for the Project Management Services category based on anticipated future workloads.

The final evaluation (including price and non-price evaluation criteria) ranked the following suppliers the highest for each of the three service categories.

Building Architectural Services:

Landscape Architectural Services:

- 3. Arcadia Landscape Architecture VIC Pty Ltd
- 4. Playce Pty Ltd
- 5. ACLA Consultants Pty Ltd

Project Management Services:

- 1. Specialised Project Management Group Pty Ltd
- 2. Projx Pty Ltd
- 3. Pure Projects Pty Ltd
- 4. Touch Projects Limited

As such, the evaluation panel recommends these suppliers as representing the best value outcome for Council.

FINANCIAL IMPLICATIONS

Council Officers have estimated future workloads for this panel based upon the Long Term Capital Works Program and Council's Long Term Financial Plan. It is estimated that the proposed panels will be engaged for approximately 15 to 20 projects per annum in each category.

The estimated annual expenditure by category is as follows:

These services will be funded from projects within Council's adopted Capital Works program.

SUSTAINABILITY OUTCOMES

As part of Council's commitment to sustainability, all contractors recommended for this panel have been evaluated and demonstrated evidence of business commitments to environmental, local, and social sustainability practices.

This includes commitments to environmental sustainability design principles and the use of sustainably sourced and high recycled content materials, water sensitive urban design and low energy resources. All contractors have committed to sourcing local materials and resources where feasible and are also commitment to providing opportunities to support young and disadvantaged communities as part of this contract.

CONCLUSION

That Council approves the recommendations contained within this report.
