# Preschool Field Officer Request Form 2024



### Preschool Field Officer service

The Preschool Field Officer (PSFO) service is a targeted and time-limited capacity-building program. All Victoria statefunded kindergarten programs are eligible to receive the PSFO service to support the access, inclusion and participation of children with additional needs in a kindergarten program.

PSFOs do not directly deliver intervention to a child within the kindergarten setting but act as a coach to the early childhood teacher. **The teacher(s) at the kindergarten service are the focus of the PSFO support**. While there needs to be a specific child referred, the purpose of the support is to guide and coach the teacher, to ensure they have the confidence and skills to best support the needs of the individual child.

## Eligibility

An early childhood teacher can access inclusion support from the PSFO service if the following criteria are met:

- A child with additional support needs is currently accessing a state-funded kindergarten place at the service. State-funded kindergarten places include:
  - 4-year-old state-funded kindergarten
  - 3-year-old state-funded kindergarten
  - Early Start Kindergarten
- 2. The state-funded kindergarten service is not currently receiving capacity-building support from the child's Early Childhood Early Intervention (ECEI) professional
- 3. The PSFO service receives a request form from the child's state-funded kindergarten service, which has been completed by the child's early childhood teacher and signed by the child's parent/guardian.

#### Privacy

Monash City Council ("Council") collects personal information via this form for PSFO service administration and related purposes, which the individual to whom the information relates may reasonably expect. Council will not release or provide access to personal information to any other person or body, unless (a) it has been authorised to do so by the person to whom the information relates, (b) it is permitted or required to do so by law, or (c) it is appropriate or required in the performance of the functions of Council. If you refuse to supply the requested information, we may not be able to process your service request.
