Council has made the unprecedented decision in its draft budget to introduce a waiver on Council rates for the 2020/21 financial year as a gesture of support for the Monash community in the wake of the COVID-19 pandemic.

The waiver is for the 2020/21 financial year on the grounds of financial hardship under section 171 of the Local Government Act 1989. This means that whilst rates will go up by an average of 2% under the State Government's Ratecapping system, Monash ratepayers will then be provided with a 10% waiver. Not raising rates by the allowed 2% would have a compounding impact on future budgets.

We believe Monash is the only Council in Victoria to propose a cut in rates across the board, recognising the impact of COVID-19. The waiver applies to all 81,319 ratepayers in Monash.

It's a decision Council has been able to make because of prudent financial planning over many years.

Monash Council remains the metropolitan Council with the lowest rates on a rate per assessment basis and the lowest rates for any Council in the State on a per capita basis.

COVID-19 has had a significant impact on everyone and no-one can be 100% sure what lies ahead economically and emotionally but we believe this draft budget strikes the right balance. When this crisis began, we promised we would be there for our community during the tough times and the recovery, and this is as tough as it gets.

The most immediate financial assistance we can give the Monash community is to reduce the amount of rates people pay, whilst still being able to maintain our essential services that we know our residents expect.

Rates contribute to Council services like rubbish collection, libraries, maintenance of roads and footpaths, sporting facilities, child immunisation and meals on wheels. These services are important to the community and we have taken steps to ensure these continue.

We will keep our end of the bargain. We will continue to do all we can to deliver the high quality services, projects and initiatives that you expect under these constrained circumstances. We will continue to work together in our partnership of community and Council in this great city of Monash.

Council has taken up the option offered by the State Government to delay the introduction of the Budget due to COVID-19. The draft Budget will go before the 25 August Council meeting for adoption.

As a result of this change, the delivery of rate notices for the 2020/21 financial year will be delayed until early September 2020. The usual 10 instalment payment plan offered by Council will therefore be reduced to 9 instalments.

# FURTHER CONSULTATION on night time cat curfew

**Council will undertake** further consultation on the introduction of a night time cat curfew (sunset to sunrise) with the community, including affected registered cat owners, local Friends groups and animal welfare organisations.

The introduction of a cat curfew in Monash is something Council has been considering for some time as a mechanism to ensure cats are kept safely indoors at night not only for their own safety and wellbeing but also to protect native wildlife and vegetation.

The introduction of a cat curfew will make it an offence for cat owners to allow their cats to roam at night. However, curfews are difficult to enforce and it is intended that through heightened awareness of the curfew and a willingness to comply with a legal control, keeping cats safely indoors at night may become everyday behaviour rather than Council actively enforcing a curfew. However, cat owners who repeatedly breach a curfew following education and warnings, can risk receiving a fine.



Council had received numerous cat complaints for some years, as well as requests for a cat curfew. which had further prompted Council to consider the matter, but between 2012 and 2016, there was a 90% reduction in cat nuisance complaints to Council.

Between June and September 2017 Council consulted on its Domestic Animal Management Plan (2017-2021) and did not include specific questions about a cat curfew but did ask about nuisance cats. An overwhelming number of respondents supported a proposition for an education campaign to keep cats indoors at night. Additionally, a number of respondents supported going further and introducing a cat curfew.

The curfew was included in the final Domestic Animal Management Plan that went to Council.

At Council's October 2017 meeting. an amendment was moved to remove the cat curfew. Four Councillors supported removing the curfew and five did not, with one Councillor abstaining and one Councillor absent. The Domestic Animal Management Plan, including the introduction of a cat curfew in December 2020, was then passed 7-3. Council decided at its May 2020 meeting to hold off introduction of a cat curfew until April 2021, when pet registrations are due.

In the interim, given a specific question about a cat curfew has not been directly asked as part of the previous consultation, particularly to registered cat owners in Monash, Council has

now determined to hold off on the introduction of the curfew until April 2021 and in the interim believes it is important to further consult with the community, including registered cat owners and wildlife groups.

What Council is proposing is for a night-time curfew, from sunset to sunrise. This does not require cat owners to make any changes to their property, <mark>such as a special</mark> cat run. It would simply require them to keep their cat indoors, whether that be inside the home, garage or shed - somewhere comfortable and safe for the cat and also for birds and wildlife.

When cats are outdoors they can attack wildlife, get hit by cars, be injured or injure other cats, and spread diseases such as feline AIDS. They can also spray, howl, and annoy neighbours, especially during mating season.

In a study by the CSIRO (We need to worry about Bella and Charlie) it found that: Pet cats kill introduced species more often than do feral cats living in natural environments, but, nonetheless, the toll of native animals killed per square kilometre by pet cats in residential areas is still much higher than the toll per square kilometre by feral cats.

## **MESSAGE FROM** Mayor Stuart James

In this issue of the Monash Bulletin we outline our 2020/21 draft budget. It's a draft Budget like never before, and it has taken months of deliberations to reach this point. It is nothing like what we planned pre-COVID-19, but in acknowledging the emotional and economic challenges our community is facing, I firmly believe that this is the budget we need to have. The key initiative is our proposal for a 10% waiver on rates for all 81,319 Monash ratepayers - residential, business and investment. To the best of my knowledge, we are the only Council in the state to propose a waiver across the board. And we do so while maintaining our status as the lowest rating Council per capita in the state.

Everyone is impacted by this pandemic. People have lost jobs, businesses are suffering, and owners of investment properties have tenants who can't pay their rent. We were not going to pick and choose who receives help, as we know everyone is struggling and everyone deserves a helping hand. But I want to reassure you that this decision will not result in a loss of those essential services that are critical to you. Services such as waste collection, road and footpath maintenance, upkeep of our reserves, sporting facilities, recreation centres and services to support our families, older residents and young people will all continue. Prudent financial management

over many years ensures that we can manage this for the short-term. And there will still be infrastructure projects that we will undertake to improve our city. It's important that you let us know what you think about the draft Budget. Please take the time to do so.

In other news, our fantastic FOGO (food organics, green organics) program has kicked off and the initial response has been one of overwhelming excitement. I'm delighted at how many of you are keen to take part - it's one of the easiest ways we can reduce our individual impact on



our environment. My two young daughters were very curious about what the little bucket was for and have been very excited to scrape their leftovers in and then deposit them in the outside bin. It's great to see their enthusiasm and to be able to have conversations with them about where the waste will go and what will be done with it - fertile compost to feed vegies. This is a great initiative to reduce waste to landfill and one I am proud to champion.

# HARD WASTE collection to start

Council's annual free hard waste collection begins this month and notices will be sent to households outlining what you can and can't put out for this collection.

The annual free hard waste collection runs from 27 July through to 31 August.

#### Some tips to remember:

- » Collections will take place between Monday-Friday of your collection week
- Total material placed on the nature strip should not exceed four cubic metres
- » Place goods on the nature strip by 6am on the Monday of your collection week, or one week before your collection is due to begin
- » Each stack will be collected

by a different truck at a different time of the week

- » Items put out for collection must be able to be lifted by two people and weigh less than 50kg
- » Please do not park your car in front of the naturestrip during the collection week
- » To keep our streets tidy for everyone, please ensure you follow the guidelines in the brochure and make sure that all items you leave out can be collected
- » If you receive a notice advising that your items cannot be collected, it will explain why they can't be picked up and we ask that you return them to your property within 24 hours.

## YOU CAN NOW recycle food waste

We're excited to let you know food waste can now go in your green waste bin – the same bin used for grass clippings and garden prunings.

You can recycle things like fruit and vegetables,

meat, fish and bones, eggshells, bread, rice, pasta, cooked leftovers and even paper towel, tissues and pet hair. Recycling your food waste is easy:

- **1. Collect food scraps in your kitchen caddy:** Have your caddy nearby when preparing meals so you can put food scraps straight into your caddy
- **2. Empty your caddy into your green waste bin:** Carry your caddy to your green waste bin, flip the lid and tip your food waste in the bin
- **3. Put your green waste bin out for collection:** Your green waste bin goes out on the alternate week

A welcome pack and caddy are currently being delivered to households who have a green waste bin. **If your caddy hasn't arrived by Wednesday 5 August call us on § 9518 3555.**  Unsure whether food waste recycling is for you? Start small by putting fruit and vegetable peelings, bread and eggshells in your green waste bin. As you become more confident, you can then add meat, bones and cooked leftovers to your green

## **Reduce smells and mess**

Odours and smells are common with food. You might be concerned about your caddy or green waste bin getting smelly but there are ways to minimise smells so you can recycle your food scraps with confidence:

- » Sprinkle bi-carbonate (baking) soda on top of the food waste.
   You can also do this in your green waste bin
- » Empty your caddy every 2-3 days and rinse it after each use. For a more thorough clean you can use dish detergent or pop it in your dishwasher.

#### Yes please

- » Fruit and vegetable peelings, scraps
- » Meat, seafood, bones
- » Noodles, rice, cooked leftovers
- » Eggshells, dairy, baked goods
- » Grass clippings, garden prunings
- » Leaves, flowers, small logs, branches.

#### No thanks

- » Plastic bags, food containers, food packaging
- » Fruit and vegetable stickers, rubber bands, labels
- » Nappies, baby wipes, pet waste.

Biodegradable, degradable or compostable items and packaging cannot go in your green waste bin. Please dispose of these in your general waste bin.

The only liners acceptable to use for food waste recycling are ones that are AS4736 certified.

# COUNCILLOR **NEWS** Cr Geoff Lake

#### The four things Council has done to support you during COVID-19

Everyone in our community has been impacted by the global pandemic. Over the past five months our families, businesses and schools have been uprooted in ways that would have been unimaginable just last year.

Unfortunately it will be many months and probably years until life returns completely to how it once was. The last fortnight has been a crushing reminder of that.

However, it has been so good to see people looking out for others in our community. Whether it has been buying groceries for vulnerable neighbours, checking in on colleagues working from home, smiling to the person you pass on the street or letting someone else grab that last roll of toilet paper at the supermarket, our collective concern for each other has been evident.

We all have a part we can play. And for an organisation like Monash Council - that is particularly so.

I'm pleased that Monash Council has really stepped up to meet these challenges.

Firstly, as councils and other businesses were laying off staff back in March and April, we resolved that we would guarantee the ongoing employment of all Council staff. They did not deserve to be thrown on the scrap heap as pools, golf courses and libraries closed - and there was no shortage of opportunities for useful redeployment.

Secondly, we made it clear that anyone (including businesses) experiencing financial hardship would not have to pay their Council rates and other charges immediately and could defer these without interest.

Thirdly, we have kept key Council services open wherever possible during the shutdown periods. We also ensured our libraries and recreation facilities reopened as soon as permitted by government restrictions. And we were one of the few councils which has kept its customer service counter and civic centre open the whole time.

Fourthly, and most importantly, we have resolved to provide a 10% waiver of rates for every ratepayer. With the exception of a fortunate few, most in our community have been financially impacted as a result of the pandemic. This won't fix that, but an average saving of around \$150 will hopefully help a little.

This is just the beginning and not the end of Council's response to the coronavirus. There is more to be done and recovery will take years. Through careful and compassionate action, we can support each other through these difficult times and our community will emerge stronger and more deeply connected at the other end.

# **COMMUNITY GRANTS** \$2.5 million boost

Council will fund almost \$2.5 million in community grants to groups and organisations within Monash in 2020/21.

Monash Council has one of the largest community grants programs in Victoria and this year 240 applications were considered.

The Grants Program has taken into account the current situation with COVID-19 and the inability of some programs and groups to operate. Funding for groups and events will be allocated when, and if, they are able to resume providing programs and services.

Council is proud of its program and its support of community groups and organisations who play a huge role in the lives of many Monash residents. Council will provide cash and inkind funding (including use of hall or printing) to 199 organisations and services who met the funding criteria including:

- » Arts and Cultural Projects -\$90,102.83
- » Community Events \$49,883.45
- » Community Strengthening -\$357,684.29
- » Neighbourhood Houses -\$475,366.81
- » Positive Ageing \$745,823.71.

Council also endorsed setting aside \$135,000 of the existing grants funds for the establishment of a Quick Response Grant Program to assist groups to reconnect with their members in innovative or alternative ways while COVID-19 restrictions are in place.



Under this program applicants can apply for up to \$5000 for a once-off grant. The grants will be open from 1 July 2020 until the allocation has been exhausted.

# COUNCIL ELECTIONS coming soon

With more than 2000-plus candidates expected to contest local government elections across Victoria, this year's election is shaping up to be one of the biggest ever.

If you are interested in running for Council and playing an important role in contributing to the future of Monash, you can find out more from the Victorian Electoral Commission (details below).

Residents can vote for their Council representatives via postal vote on Saturday 24 October.

Every four years, Monash residents and ratepayers vote to elect 11 Councillors to represent the community in four wards: Glen Waverley, Mount Waverley, Oakleigh

and Mulgrave.

Three Councillors are elected in Mount Waverley, Oakleigh and Mulgrave wards and two in Glen Waverley.

In April 2020 a review of Monash Council boundaries was completed and a recommended change was made to the Glen Waverley and Oakleigh wards.

### This includes:

- » An extension of Glen Waverley Ward to include an area with the boundary of Springvale Road, Waverley Road, Blackburn Road and the Monash Freeway. This change affects 4,093 voters in Mount Waverley Ward that will now be in Glen Waverley Ward
- » Extending the Mount Waverley/ Oakleigh Ward boundary south to Ferntree Gully Road. This change affects
   1,011 voters in the Oakleigh ward that will now vote in the Mulgrave ward.

Council elections are conducted by the Victorian Electoral Commission (VEC) as required under the Local Government Act 1989.

Since 1997, Monash Council has used the postal method of voting, rather than attendance voting, as postal voting is considered the most efficient and accessible method of voting.

# The last election was held in late October 2016.

Are you interested in running for Council? As a Councillor you play an important role in making Monash a great place to live now and in the future. The role of women on Council is also critical as a representative voice.

# **HIGHLIGHTS** from Council's draft 2020/21 Budget

#### Council has secured State and Federal funding as part of the COVID-19 recovery packages to put towards key infrastructure projects:

### MAJOR PROJECTS

A further \$4.57M towards the Oakleigh Recreation and Waverley Gymnastics Centre, including Federal Government funding of \$2.39M, external contribution of \$750K and Council contributions of \$1.44M. The project will be completed in 2020 with a total budget of \$25.2M.

## **ROADS AND FOOTPATHS**

# Various road reconstruction programs \$4.48M, which includes:

\$1.48M external grant funding, \$3.25M to renew Council's footpaths (estimated up to 40,000m<sup>2</sup>) and \$1.2M to address the resurfacing of local roads in keeping with community expectations.

## **SPORTING FACILITIES**

The State Government, through Sport and Recreation Victoria, has committed \$2M towards the improvement of eight outdoor netball courts at Jells Park. Detailed design is complete and total project costs including the outdoor courts precinct plan is \$2.40M Council's contribution to the project is \$397K.

Construction of a multi-sport pavilion at Caloola Reserve \$2M to complement the completed tennis courts at the site.

\$1.92M for construction commencement of the Brentwood Reserve Pavilion.

Design and construction of Mulgrave Reserve pavilion will proceed at an estimated cost of \$1.80M plus carry forward \$150K from last year, including a state grant of \$900K.

## CHILDREN AND FAMILIES

\$2.25M to continue the design and planning of an Integrated Child & Family Hub at Wellington Kindergarten & Mulgrave Park in year 2. This project will be completed by 2021/22 with a total budget of \$4.52M, including \$1M in grants from the State Government
